What We Do

Since 1993, National Child Day has been celebrated in Canada on November 20th. National Child Day commemorates the United Nations' adoption of two documents centered on children's rights: the *United Nations Declaration of the Rights of the Child* on November 20, 1959, and the *United Nations Convention on the Rights of the Child* on November 20, 1989.

By ratifying the *United Nations Convention on the Rights* of the Child in 1991, Canada made a commitment to ensure that all children are treated with dignity and respect. This commitment includes the opportunity for children to have a voice, be protected from harm, and be provided with their basic needs and every opportunity to reach their full potential. Celebrating National Child Day is about celebrating children as active participants in their own lives and in communities, and as active citizens who can and should meaningfully contribute to decision-making.

The Advocate for Children and Youth (ACY) annually celebrates this important day. This year, two staff members set up an information booth at the Newfoundland and Labrador (NL) Youth Centre's first Youth Information

Day on October 23 in Whitbourne, NL, and at the City of St. John's Move It Family Fun Day on November 22. These types of opportunities allow staff members to connect with children, youth and other members of the public while educating them about the rights of children, and the ACY's mandate to protect and advance the rights and interests of children and youth in NL.

Out and About

As part of our outreach program, staff from the office travel to various parts of the province throughout the year and meet with the public, professionals, and children and youth. In addition to educating people about children's rights, we reach out to communities across the province to provide information about what we do and how we can assist in advocating for children and youth. Our staff also take the time to educate ourselves and make connections in the community through various education sessions and opportunities for professional development. We are always looking for ways to learn more about other agencies in the Province and to connect with professionals working with children and youth.

Celebrating Children's Rights

National Child Day is celebrated in Canada on November 20 in recognition of the *UN Declaration on the Rights of the Child* and the *UN Convention on the Rights of the Child*. Article one of the *Convention* defines a child as all people less than 18 years of age; which means everyone under this age of majority enjoys the rights celebrated on November 20th of each year.

How can I celebrate National Child Day?

- Learn more Read about National Child Day and the *UN Convention on the Rights of the Child.*
- Empower young people to use their voice Provide them with a copy of the youth-friendly version of the *UN Convention on the Rights of the Child* to remind our children and youth about their rights and how they can protect the rights of others.
- Raise awareness Use the spoken word, written word, or social media to start conversations about National Child Day with friends, family members, fellow students, and co-workers.
