## What's New

From July 12th to July 19th, 2013 the second annual International Summer Course on the Rights of the Child was held in Moncton New Brunswick at the Universite de Moncton. One of our Systemic Advocacy Consultants attended this course and found it to be very beneficial.

The course was a partnership between the University and the

New Brunswick's Child and Youth Advocate. The course was offered in English and French, allowing all attendees the ability to participate. Each year a theme for the course is chosen based on an Article from the United Nations Convention on the Rights of the Child (UNCRC). The theme for the 2013 Course focused on Article 19: The Right to Protection.

Participants came from Child and Youth Advocate Offices across the country, government agencies and advocacy groups from Canada and other parts of the world.

The course discussed a variety of topics including Children in Armed Conflict, Physical Punishment, the Neurology of Violence

and Victimization/Abuse of Children and Effective Treatment. The most powerful presentation came from youth who had grown up In Care, and who shared their stories of what it was like to "Be In Care". The presentation was eye opening and it was amazing to see the youth's courage and resiliency which has allowed them to overcome challenges in their lives.

The course also offered opportunities for participants to network and attend social events such as a cultural day trip, a children's concert and the closing ceremony.

The third edition of this course will take place July 2014 and will focus on Article: 12: The Right to Participate.

### **Out & About**

The mandate of the Advocate for Children and Youth (ACY) includes the legislated responsibility to ensure the rights, interests and viewpoints of children and youth are protected and advanced. In order to meet our mandate and as part of our Provincial Outreach Program, the ACY is committed to completing quarterly visits to regions across Newfoundland and Labrador. The purpose of these visits is to educate children, youth, service providers and others on the role and mandate of the Office, as well as children's rights and responsibilities

# The "Rights" Stuff

#### Article 42- The Right to Know Your Rights

Article 42 of the United Nations Convention on the Rights of the Child: "States parties undertake to make the principles and provisions of the Convention widely known, by appropriate and active means, to adults and children alike."

The Committee on the Rights of the Child understands that Rights are of little use to people unless they are aware of them. We all must be "active" in our efforts to educate the public about children's rights.

#### Why Teach Children about their Rights?

- 1. Build social skills Education about rights helps children understand the importance of treating people equally and protecting the rights of others.
- 2. Motivate future learning Helping children realize how fortunate they are to have the right to be educated leads to an understanding about the significance of life-long learning.
- 3. Creates safer schools and playgrounds By providing children with the opportunity to model their rights and responsibilities we may reduce exclusion and bullying.
- 4. Children know their rights Children gain an appreciation of rights and begin to view their lives from a global perspective.
- 5. Empower children to become active citizens Teaching children about the importance of defending human rights builds a generation that is socially responsible.
